Notice of Annual Stockholders' Meeting and Information Statement

AgWest Farm Credit, an Agricultural Credit Association (AgWest Farm Credit)

As a Member of AgWest Farm Credit, PCA or AgWest Farm Credit, FLCA, you own stock in AgWest Farm Credit. You are invited to attend AgWest Farm Credit's Annual Stockholders' Meeting (Annual Meeting) on September 18, 2024, at 9:00 a.m. (PDT) at AgWest Farm Credit's headquarters located at 2001 S. Flint Road, Spokane, WA, or you may attend with an online/telephonic option. You can attend the Annual Meeting virtually through an emailed meeting link that can be accessed on your preferred device or through a toll-free number with a conference identification code. Please visit AgWestFC.com/2024AnnualMeeting or call 866-552-9172 to register for the Annual Meeting and get additional details about meeting attendance options. If you register to attend the Annual Meeting through the online/telephonic option, this registration shall constitute your consent and agreement to the use of electronic communications by AgWest Farm Credit to conduct the Annual Meeting. Your consent is limited solely to the Annual Meeting and shall not apply as consent to any other electronic business communication with AgWest Farm Credit.

You are not required to participate in the Annual Meeting to vote in the board and Nominating Committee elections. Voting will be conducted by mail, with an online voting option. Following the Annual Meeting, ballots and detailed voting information, including additional director candidate biographical information, will be mailed to all Voting Members, as defined in AgWest Farm Credit's Bylaws ("Bylaws") designated as of August 5, 2024 (the "Record Date"). Information on the 2024 director and Nominating Committee elections and other related governance matters will be provided at the Annual Meeting. Director candidates nominated by the Nominating Committee will be presented for election at the Annual Meeting, followed by a call for floor nominations.

We appreciate your business and look forward to serving you in 2024 and beyond.



Director and Nominating Committee Elections

As set forth in the Bylaws, the Board of Directors (the board) consists of 22 directors; 20 positions are held by Members who own voting stock and are elected by Voting Members, and two positions are held by board-appointed Outside Directors, as defined in the Bylaws (and as required by FCA Regulation). All directors serve jointly as the board of AgWest Farm Credit, ACA, PCA and FLCA. Except as provided for in the Board Transition Plan in the Bylaws, director terms are five years.

In 2024, three stockholder-elected director positions are up for election. All voters will be asked to:

- (a) vote for one director candidate in Position 1 and one director candidate in Position 2, both of which are from Region 3 (Idaho) and one director candidate in Position 3 from Region 7 (Coastal California) to serve on the board; and
- (b) vote for candidates to serve on the 2025 Nominating Committee.

All Voting Members may vote for any candidate, regardless of region. An independent third-party will tabulate and certify voting results following the voting cut-off date. Results will be posted on AgWestFC.com and mailed to all Members in October.

Voting Cut-off and Floor Nominations

Additional director candidate biographical and educational information will be provided with the ballots to be mailed to Voting Members following the Annual Meeting. To be counted, ballots must be received by mail or cast online by the voting cut-off date of October 15, 2024 (which may be postponed to approximately November 1 in the case of a floor nomination at the Annual Meeting).

The Bylaws allow floor nominations for stockholder-elected director positions, which can be made only when called for at the Annual Meeting, after the Nominating Committee's slate of candidates for the 2024 director elections has been presented. A Voting Member must be present (online/telephonically or in person) at this meeting to make a floor nomination or to be nominated from the floor. Candidates may not nominate themselves and the nomination must be made by another Voting Member who is assigned to the nominating region in which they are making the nomination. The nominee may be nominated only to a position up for election within the region to which the nominee is assigned.

A second by another Voting Member to a nomination from the floor is required, and the nominee must affirmatively state that they accept the nomination. The eligibility of an individual making a floor nomination will be verified following the Annual Meeting. A person nominated from the floor must meet all eligibility requirements for board service and must provide all disclosures required by the Bylaws, board policies and FCA regulations within five business days after being nominated. Floor nominees will be given the same opportunity provided to the individuals on the existing slate of candidates to:

- (a) provide biographical and educational information about themselves to Voting Members to be mailed with the ballots; and
- (b) record a message to be posted with other candidates' messages on AgWestFC.com during the voting period following the Annual Meeting.

Record Date

The Record Date is August 5, 2024. Only Voting Members as of the Record Date may vote in the 2024 elections.

Voting Requirements

For each of the three director positions up for election, a majority of votes cast will determine the winner. If there are more than two candidates for a position, a plurality of votes will determine the winner. Only Voting Members can vote.

Disclosure Information

AgWest Farm Credit has reviewed the required disclosures submitted by the non-floor nominated director candidates, including loan transactions, family relationships with customers and employees of AgWest Farm Credit, transactions other than loans, certain legal proceedings (bankruptcy, criminal proceedings and injunctions) and conflicts of interest, and determined that the 2024 director candidates meet eligibility requirements. AgWest has also reviewed required

disclosures of current directors and Senior Officers made since issuance of the Annual Report and determined there are no matters to be disclosed to shareholders as required by regulation.

Attendance at Meetings

All current directors have attended at least 75 percent of board and committee meetings in the last fiscal year.

Quorum Requirements

Seventy-five (75) Voting Members or one percent of the total number of Voting Members of AgWest Farm Credit, whichever is less, shall constitute a quorum at a meeting of Members. Mail ballots shall be included to establish a quorum as provided in the Bylaws.

AgWest's Annual Report

The 2023 Annual Report for AgWest was mailed to all Members on March 29, 2024 and is posted on AgWestFC.com. The 2024 AgWest Annual Report will be mailed to all Members and posted on the website no later than March 31, 2025. Copies of the Annual Report as well as copies of quarterly reports are also available from AgWest Farm Credit free of charge by calling 866-552-9172 or sending a written request to P. O. Box 2515, Spokane, WA 99220.

Nominating Committee

There are two candidates for each of the 12 Nominating Committee positions up for election in 2024. Voting Members will be asked to vote for Nominating Committee candidates to serve on the 2025 Nominating Committee on the ballots mailed following the Annual Meeting. Each Nominating Committee member must own voting stock in AgWest Farm Credit and meet eligibility requirements set forth by the board and federal regulation. Eligibility of each candidate has been confirmed. Floor nominations for Nominating Committee positions are not allowed. The candidate receiving the most votes in each position will serve on the 2025 Nominating Committee and the candidate receiving the least votes in each position will serve as alternate. As provided for in the Nominating Committee's Charter, should a committee member be unable to attend the first meeting in person, the alternate in that position will be asked to attend in their place and fulfill the remainder of the term.

Once elected, the Nominating Committee will be responsible for:

- (a) selecting candidates to run in the 2025 director elections in Regions 4 (Oregon), 6 (Southern San Joaquin Valley) and 8 (Southwest); and
- (b) selecting candidates to be voted on to serve on the 2026 Nominating Committee. The 2025 Nominating Committee candidates are on page 8.

In the ordinary course of business, AgWest Farm Credit may enter into loan transactions with directors and director nominees, their immediate families, their affiliated organizations, and immediate family members and affiliated organizations of Senior Officers. Such loans are made on the same terms, including interest rates and collateral, as those prevailing at the time for comparable transactions with unrelated borrowers. Senior Officers and certain immediate family members and affiliated organizations are precluded from obtaining new loans from AgWest Farm Credit.

In the ordinary course of business, AgWest Farm Credit may enter into certain other non-lending transactions with directors, Senior Officers, and their family members and affiliated entities. These products and services are available to all customers at the same rates and terms and are not special or extra benefits unavailable to all stockholders.

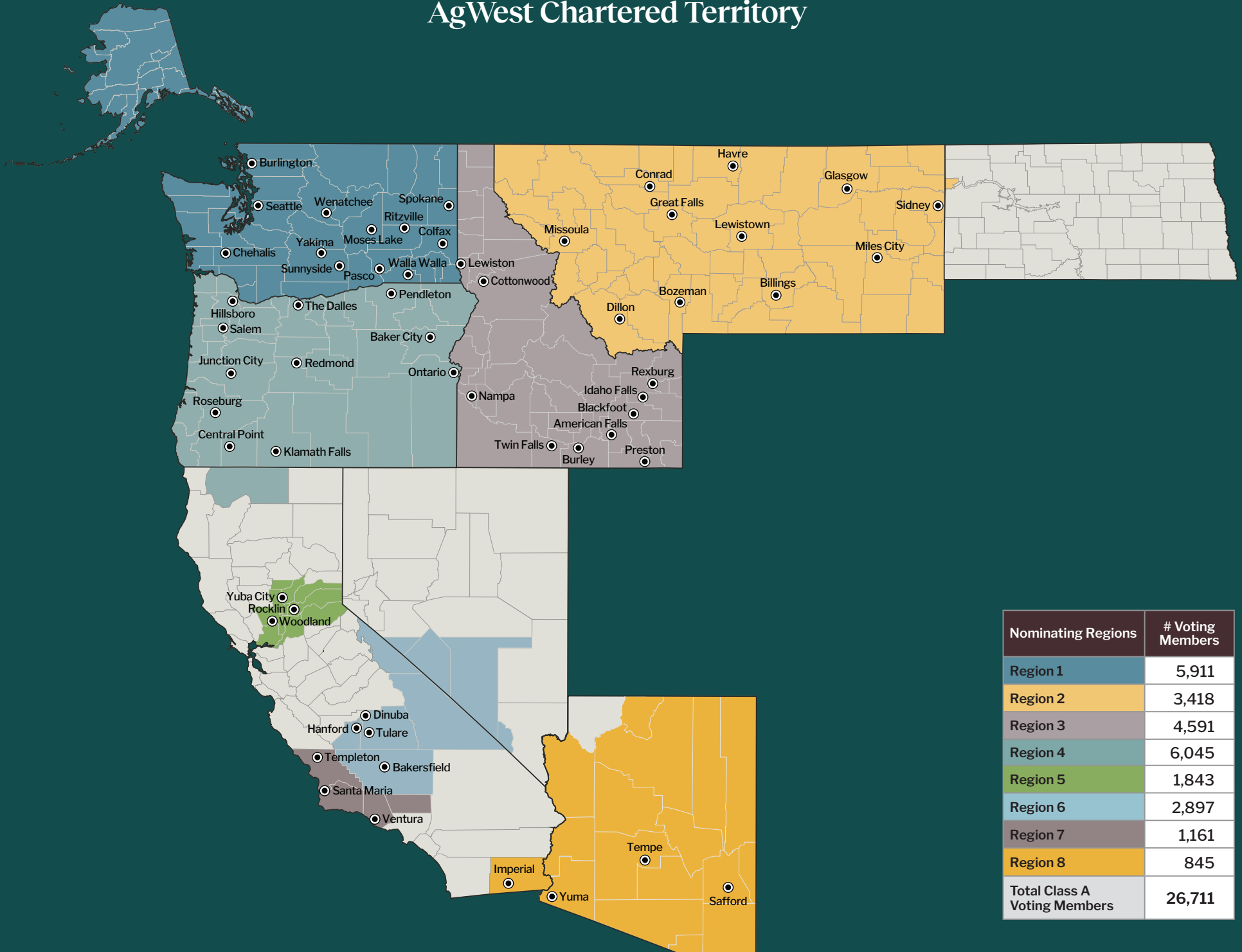

The Boettchers have been in that area for over 100 years.</p>
	<p>Trevor Dorland, Walla Walla, WA (Walla Walla Branch): Trevor is the CFO of Cayuse Winery, owning roughly 50 acres of premium vineyard in the Rocks District AVA south of Walla Walla, WA. The vineyards are farmed biodynamically – a chemical free approach designed to produce healthier soil and a better product. The wines produced have won numerous awards over the past two decades.</p>

	<p>Susan Whittaker, Leadore, ID (Idaho Falls Branch): Susan and her husband Jordan own a large cow-calf operation located in Leadore and operate an irrigation supply business providing sales, installation, and service of pivot irrigation systems. They also own and operate two hydroelectric power generators using irrigation water to generate and sell electricity.</p>

	<p>Jonathan Lavy, Yuba City, CA (Yuba City Branch): Jon is an owner of Lavy Brothers Farming out of Biggs, CA. They farm walnuts, rice, pecans and almonds in Butte and Sutter Counties.</p>

Position 8	<p>Mike Frey, Bakersfield, CA (Kern County Branch): Mike is a partner in the Buttonwillow Land and Cattle Company which grows almonds and pistachios, wine grapes and field crops including carrots, chipper potatoes, cotton, corn silage, wheat and alfalfa.</p>
